New Off Licence under Sale and Supply of Alcohol Act 2012:

Please find attached your new Off Licence, along with copies of the relevant reports.

I wish to draw your attention to the following:

1. The licence will need to be renewed in accordance with the relevant sections of the Act. You should familiarize yourself with the provisions of sections 125 to 132 of the Sale and Supply of Alcohol Act 2012.
2. The requirement to display signage and a copy of the licence in terms of sections 56 & 57 of the Act.
3. The requirement of every licensee to notify an address for service to the Secretary of the Licensing Authority in terms of section 68 of the Act.
4. The need to appoint a manager or managers in accordance with the Act if the licence has been issued to a company, licensing trust, partnership, Government Department or other instrument of the Crown, or local authority.
5. Any other holder of an Off Licence may also appoint a manager or managers in accordance with that part of the Act.

IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Wrapped NZ Limited for a new OFF licence pursuant to Section 100 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 33 Hinekura Avenue, Taupo and known as "Wrapped NZ"

THE APPLICATION:

This is an application by Wrapped NZ Limited for an Off Licence in respect of premises situated at 33 Hinekura Avenue, Taupo, known as "Wrapped NZ". It was formally received by the Taupō District Licensing Committee on 2nd November 2021. The general nature of the business to be undertaken is the sale of gift boxes/hampers where the sale of alcohol will be complimentary to the other goods sold.

The application was duly advertised in the "Taupo Times" newspaper on 5 November 2021 and on 12 November 2021 and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

REASONS FOR THE DECISION:

The applicant seek an off licence under the section 35 exception of the Act that permits a licence to be issued where the Committee believes the sale of alcohol is complimentary to the other items sold by the business.


The Police and Medical Officer of Health reports raise no matters in opposition.

THE DECISION:

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant an Off Licence authorising the sale and supply of alcohol for consumption off the premises.

The licence shall be subjected to specific conditions as detailed in the attached licence.

OFF LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Wrapped NZ Limited** is authorised to sell or deliver alcohol on or from the premises situated at 33 Hinekura Avenue, Taupo, and known as **Wrapped NZ**, **to any person for consumption off the premises**.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager, or managers, appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold from the premises at any time on any day, and delivered somewhere else for consumption off the premises, but only on the following days and hours: Monday to Sunday from 8.00am to 6.00pm.
2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00pm on Anzac Day.
3. Alcohol can only be sold as part of a gift basket/ hamper that contains other non-alcoholic items or products.
4. No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time between 11.00pm and 6.00am the following day, on any day of the week.
5. There must be a certificated manager properly appointed to the business by the licensee.
6. The licensee must follow the procedures set out in Regulations 14 & 15 of the Sale and Supply of Alcohol Regulations 2013, to ensure that neither the purchaser nor the person to whom alcohol is delivered to is a minor.
7. The licensee must state the licensee's name, the licence number and the date the licence expires:
 - a. on every receipt issued for alcohol sold remotely,
 - b. in every catalogue, if alcohol is sold by remote sale using catalogues,
 - c. on the internet site, if alcohol is sold by remote sale using an internet site,
 - d. if alcohol is sold by remote sale using an internet site, the site must also display either a legible image of the licence, or a clearly identified link to such an image.

THE LICENSED PREMISES

The sale or delivery of alcohol is authorised in or from the premises generally. The premises situated at 33 Hinekura Avenue, Taupo, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 2 November 2021.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

This licence expires on 3 December 2022 unless further renewed
